Organisation & Responsibilities

At Regional level the respective Regional Chairman, Managing Director and Construction Director are responsible for ensuring compliance.

The Group Health, Safety & Environment (HS&E) Department sets the policy and undertakes regular auditing of all construction sites and provides suitable and sufficient training to ensure compliance with this policy. In addition, all persons employed or working at any Persimmon site have degrees of responsibility for health, safety and environmental matters, which is communicated to them via their individual roles and responsibilities.

The Managing Director is also responsible for completing Directors and Heads of Department Responsibility Chart and to keep this under review.
