



The Safe use of D4 Adhesive (Diisocyanates) Guidance

Introduction

The UK Government has put in force a new restrictions on the use of products containing more than 0.1% of monomeric diisocyanatos. These new rules will also apply to products such as polyurethane adhesives, sealants and foams used in industrial production and construction work. This is under the REACH Regulations (REACH stands for Registration, Evaluation, Authorization and Restriction of Chemicals Regulation)

Diisocyanates are a chemical that is contained in the D4 adhesive, that carpenters use to glue the Tonge and Groove chipboard flooring (Commonly known as Caberdek/ Egger Board), once the product is cured diisocyanates are no longer a hazard. All professionals and industrial users must complete training before using these products.

Training

Anyone using these products must be trained, this includes directly employed carpenters and sub-contractors, copies of the training certificates must be readily available on site for all operatives that use D4 adhesive.

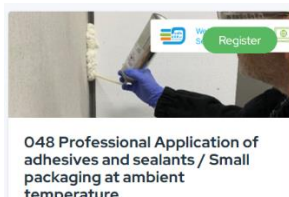
